**Bye-Laws tal-2012 dwar Xorb f'Kontenituri tal-Ħgieg  
f'Postijiet Pubbliċi (Kunsill Lokali L-Imsida)**

BIS-SAĦĦA tas-setgħat mogħtija bl-artikoli 33, 34, 35(8) u 60 tal-Att dwar Kunsilli Lokali, il-Kunsill Lokali L-Imsida għamel il-*Bye-Laws* li ġejjin:-

**1.** It-titolu ta' dawn il-*Bye-Laws* hu *Bye-Laws* tal-2012 dwar Xorb f'Kontenituri tal-Ħgieg f'Postijiet Pubbliċi (Kunsill Lokali L-Imsida). Titolu.

**2.** F'dan il-*Bye-Laws*, kemm-il darba r-rabta tal-kliem ma tkunx meħtieġ xort'ohra: Tifsir.

"arei msemija" tfisser dawk l-arei msemija minn awtoritajiet kompetenti għat-tqegħid ta' mwejjed u siggijiet sabiex jiġi kkunsmat ikel u xorb;

"l-Att" tfisser l-Att dwar Kunsilli Lokali; Kap. 363.

"kontenitur tal-ħgieg" tinkludi fliexken, tazzi u, jew xi kontenituri tal-ħgieg ieħor maħsub biex fih jiġi servut xi xorb;

"il-Kunsill" tfisser il-Kunsill Lokali L-Imsida;

"lokalità" tfisser il-lokalità tal-Imsida;

"post pubbliku" tfisser it-toroq ġewwa l-lokalità tal-Imsida kif murija fl-Iskeda A;

"toroq" tfisser dawk it-toroq kif murija fl-Iskeda A.

**3.** Ebda persuna ma tista' titlajja f'xi post pubbliku filwaqt li tixrob minn xi kontenitur tal-ħgieg. Tlajjar waqt li wiehed jixrob minn kontenitur ta' ħgieg.

**4.** Ebda persuna ma tista' ġgorr xorb alkoħoliku jew xorb ieħor f'post pubbliku jekk mhux f'kontenitur issigillat u li ma jkunx miftuħ. Garr ta' kontenituri tal-ħgieg li jkun fihom l-alkoħol.

**5.** Ebda persuna ma tista' tikkonsma xorb alkoħoliku jew xorb ieħor f'kontenitur tal-ħgieg f'postijiet pubbliċi ħlief fl-arei msemija. Konsum ta' alkoħol f'arei msemija.

Stabbilimenti  
kummerċjali.

**6.** Kull stabbiliment kummerċjali li jkun jinsab fil-lokalità jbiegħ ix-xorb għandu:

(a) jwaħħal avviż bil-Malti kif ukoll bl-Ingliż kif muri fl-Iskeda B, u dak l-avviż għandu jintwera f'post fejn ikun jidher sew u jinqara faċilment mill-klijenti tal-istess stabbiliment kummerċjali; u

(b) jipprovdi kontenituri magħmulin minn materjal li ma jkunx ħġieġ jekk dan ix-xorb ikun ser jiġi kkunsmat f'xi post pubbliku.

Reati u pjeni.

**7.** Kull persuna li tikser xi dispozizzjoni ta' dawn il-*Bye-Laws* tehel, meta tinsab hatja, ammenda ta' hamsa u sittin euro (€65.00) għal dik il-kontravvenzjoni, kif ukoll ammenda oħra ta' għaxar euro (€10.00) għal kull jum li fih tkun kisret xi waħda mid-disposizzjonijiet ta' dawn il-*Bye-Laws*.

**LOCAL COUNCILS ACT  
(CAP. 363)**

**Beverages in Glass Containers in Public Places  
(L-Imsida Local Council) Bye-Laws, 2012**

IN exercise of the powers conferred by articles 34, 35(8) and 60 of the Local Councils Act, the L-Imsida Local Council has made the following Bye-Laws:-

1. The title of these Bye-Laws is the Beverages in Glass Containers in Public Places (L-Imsida Local Council) Bye-Laws, 2012. Citation.
2. In these Bye-Laws unless the context otherwise requires: Interpretation.
  - "the Act" means the Local Councils Act; Cap. 363.
  - "the Council" means the L-Imsida Local Council;
  - "designated areas" means those areas designated by the competent authorities for the placement of tables and chairs exclusively for the consumption of food and beverages;
  - "locality" means the L-Imsida locality;
  - "glass container" includes glass bottles, glasses and, or any other glass containers intended for the serving of any beverages;
  - "public place" means the streets including pavements, squares and public gardens, within the locality listed in Schedule A;
  - "streets" means those streets listed in Schedule A.
3. No person is permitted to loiter in any public place whilst drinking from a glass container. Loitering while drinking from a glass container.
4. No person is permitted to carry in any public place alcohol or any other drinks in glass containers other than in a sealed unopened container. Carrying of glass containers containing alcohol.
5. No person is permitted to consume beverages or alcohol in glass containers other than in the designated areas. Consumption of alcohol in designated areas.

Commercial establishment.

**6.** Any commercial establishment situated in the locality selling beverages shall:

(a) affix a notice in Maltese as well as in English as shown in Schedule B, which notice shall be placed in a conspicuous place and be easily legible by the patrons of such commercial establishment; and

(b) provide containers made of a material other than glass if such beverage is to be consumed in any public place.

Offences and penalties.

**7.** Any person who is in breach of any of the provisions of these Bye-Laws shall, on conviction, be liable to a fine (*ammenda*) of sixty-five euro (€65.00) for such contravention, and to a further fine (*ammenda*) of ten euro (€10.00) for every day during which any of the provisions of these Bye-Laws is breached.
