**A Bill  
entitled**

*AN ACT to amend various laws relating to the classification of films and of dramatic and other stage productions.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:-

**1.** The short title of this Act is the Various Laws (Classification of Films and of Dramatic and other Stage Productions) (Amendment) Act, 2012. Short title.

**PART I: Amendments to the Code of Police Laws**

**2.** This Part amends the Code of Police Laws, and it shall be read and construed as one with the Code of Police Laws, hereinafter in this Part referred to as "the Code". Amendment of the Code of Police Laws. Cap. 10.

**3.** Paragraph (e) of sub-article (1) of article 203 of the Code shall be deleted. Amendment of article 203 of the Code.

**PART II: Amendments to the Malta Council for Culture and the Arts Act**

**4.** This Part amends the Malta Council for Culture and the Arts Act and it shall be read and construed as one with the Malta Council for Culture and the Arts Act, hereinafter in this Part referred to as "the principal Act". Amendment of the Malta Council for Culture and the Arts Act. Cap. 444.

**5.** Immediately after sub-article (3) of article 33 of the principal Act there shall be added the following new sub-article: Amendment of article 33 of the principal Act.

"(4) The Minister may make regulations in respect of the classification of cinema and dramatic and other stage productions and the procedure related thereto."

### **Objects and Reasons**

The objects of this Bill are to facilitate the establishment of a system for the classification of cinema and dramatic and other stage productions, and to transfer the laws regulating the classification of cinema and dramatic and other stage productions from the competence of the Ministry responsible for the Police to the competence of the Ministry responsible for Culture.
