(CAP. 169)****Commissioner of Land (Transfer of Rights and Liabilities)  
Order, 2012**

IN exercise of the powers conferred by article 2 of the Commissioner of Land Ordinance, the President of Malta has made the following order:-

- Citation.                   **1.** The title of this Order is the Commissioner of Land (Transfer of Rights and Liabilities) Order, 2012.
- Specified land.           **2.** The land described in article 4 is hereby specified for the purpose of article 2 of the Commissioner of Land Ordinance.
- Appointed day.           **3.** The rights and liabilities in respect of the land -
- (a) specified in article 4(a) of this Order shall, with effect from the 1st September, 2011 be deemed to have been exercised by Malta Industrial Parks Limited (C 28965) as provided in the aforesaid article 2 of the Ordinance; and
- (b) specified in article 4(b) of this Order shall, with effect from the 1st September, 2011 be deemed to have ceased to be exercised by Malta Industrial Parks Limited (C 28965) and shall be transferred back to the Commissioner of Land as provided in the aforesaid article 2 of the Ordinance.
- Description.              **4.** The land referred to in article 2 of this Order consists of -
- (a) an area of land, including any building thereon, at Hal-Far, limits of Birzebbuga shown edged in red on plan P.D. No: 9\_92\_7\_C, which plan is enrolled in the Records of Notary Diana Charles by virtue of a deed of the 24<sup>th</sup> August, 2011; and
- (b) two sites, including any buildings thereon, at Hal-Far, limits of Birzebbuga shown dotted in red and marked A and B on plan P.D. No: 9\_92\_7\_C, which plan is enrolled in the Records of Notary Diana Charles by virtue of a deed of the 24<sup>th</sup> August, 2011.
