IN exercise of the powers conferred by article 7 of the Agriculture and Fishing Industries (Financial Assistance) Act, the Minister for Resources and Rural Affairs, in concurrence with the Minister of Finance, the Economy and Investment, has made the following regulations:-

**1.** The title of these regulations is the Paying Agency (Amendment) Regulations, 2012, and these regulations shall be read and construed as one with the Paying Agency Regulations, hereinafter referred to as "the principal regulations".

**2.** In regulation 2 of the principal regulations, for the definition "competent authority" there shall be substituted the following definition:

" "competent authority" means the Funds and Programmes Division within the Office of the Prime Minister;".
