**EDUCATION ACT
(CAP. 327)****Bye-Laws of 2012 to amend the Bye-Laws of 2011 in terms of the
General Regulations for University Undergraduate Awards, 2004
for the Higher Diploma in Administration and Management
under the auspices of the
Faculty of Economics, Management and Accountancy**

IN EXERCISE of the powers conferred upon him by articles 74 (5) and 75 (6) of the Education Act (Cap. 327), the Chancellor of the University of Malta has promulgated the following bye-laws made by the Board of the Faculty of Economics, Management and Accountancy in virtue of the powers conferred upon it by article 81 (1) of the said Act and which have been approved by the Senate of the University of Malta as required by article 81 (2) of the said Act:

Citation

1. These bye-laws may be cited as the Bye-Laws of 2012 to amend the Bye-Laws of 2011 in terms of the General Regulations for University Undergraduate Awards, 2004 for the Higher Diploma in Administration and Management, and shall be read and construed as one with the Bye-Laws of 2011 in terms of the General Regulations for University Undergraduate Awards, 2004 for the Higher Diploma in Administration and Management, under the auspices of the Faculty of Economics, Management and Accountancy, published as Legal Notice 356 of 2011, hereinafter referred to as “the principal bye-laws”.

Applicability

2. These bye-laws shall be applicable for courses commencing in October 2011 or later.

Amendment to title of the principal bye-laws

3. In the title of the principal bye-laws, in the Maltese version, for the words “Higher Diploma in Marketing and Sales Management” there shall be substituted the words “Higher Diploma in Administration and Management”.

Amendment to bye-law 1 of the principal bye-laws

4. For paragraph (2) of bye-law 1 of the principal bye-laws, in the Maltese version, for the words “Higher Diploma in Marketing and Sales Management” there shall be substituted the words “Higher Diploma in Administration and Management”.
