**FINANCIAL ADMINISTRATION AND AUDIT ACT
(CAP. 174)**

Public Procurement (Amendment) Regulations, 2012

BY VIRTUE of the powers conferred by article 4 of the Financial Administration and Audit Act, the Minister of Finance, the Economy and Investment has made the following regulations:-

1. The title of these regulations is the Public Procurement (Amendment) Regulations, 2012, and these regulations shall be read and construed as one with the Public Procurement Regulations, hereinafter referred to as the "principal regulations".
