**JUDGES AND MAGISTRATES
(SALARIES) ACT
(CAP. 175)**

Judges and Magistrates (Revision of Salaries) Order, 2012

IN exercise of the powers conferred by articles 2 and 3 of the Judges and Magistrates (Salaries) Act, hereinafter referred to as “the Act”, the Prime Minister has made the following order:-

Citation and commencement

1. The title of this order is the Judges and Magistrates (Revision of Salaries) Order, 2012, and it shall be deemed to have come into effect on the 1st January, 2012.

Revision of salaries of Chief Justice, other Judges and Magistrates

2. There shall be paid to the holders of the offices specified in the first column of the Schedule hereto, instead of the salaries prescribed in articles 2 and 3 of the Act, the annual salaries respectively specified for each such office in the second column of that Schedule.
