IN exercise of the powers conferred by article 28(1) of the Malta Resources Authority Act, the Minister for Resources and Rural Affairs, after consultation with the Malta Resources Authority, has made the following regulations:-

Citation.

1. The title of these regulations is the Feed-in Tariffs (Electricity Generated from Solar Photovoltaic Installations (Amendment) Regulations, 2012, and these regulations shall be read and construed as one with the Feed-in Tariffs (Electricity Generated from Solar Photovoltaic Installations Regulations, hereinafter referred to as "the principal regulations".

2. In items 1 and 2 of the Second Schedule to the principal regulations, for the words "in the years 2010 and 2011", wherever they occur, there shall be substituted the words "in the years 2010, 2011 and the first six months of 2012".
