| Citation. | 1. The title of this Order is the Commissioner of Land (Transfer of Rights and Liabilities) (No. 5) Order, 2012. |
| Specified land. | 2. The land described in article 4 is hereby specified for the purpose of article 2 of the Commissioner of Land Ordinance. |
| Appointed day. | 3. The rights and liabilities in respect of the land specified in article 4 shall, with effect from the 1st September, 2011 be deemed to have been exercised by Malta Industrial Parks Limited (C 28965) as provided in the aforesaid article 2 of the Ordinance. |
| Description. | 4. The land referred to in article 2 of this Order consists of an area of land, including any building thereon, at Marsa shown bordered in red on plan P.D. 7_92_B, which plan is enrolled in the Records of Notary Diana Charles by virtue of a deed of the 16th June 2011. |
| Revocation of certain legislation. | 5.
