1. **CODE OF ORGANIZATION AND CIVIL PROCEDURE
(CAP. 12)**

**Code of Organization and Civil Procedure (Schedule A)
(Amendment) Regulations, 2012**

IN exercise of the powers conferred by article 1004 of the Code of Organization and Civil Procedure, Minister for Justice, Dialogue and the Family, with the concurrence of the Minister of Finance, the Economy and Investment, has made the following regulations:-

Title. **1.** The title of these regulations is the Code of Organization and Civil Procedure (Schedule A) (Amendment) Regulations, 2012 and these regulations shall be read and construed as one with
Cap. 12. Schedule A to the Code of Organization and Civil Procedure, which Schedule is hereinafter in these regulations referred to as "the Schedule".

Amends Tariff D of the Schedule. **2.** In Tariff D of the Schedule immediately after paragraph 11 there shall be inserted the following:

"11A For the filing of any warrant issued for the purpose of enforcing a decision of the Consumer Claims Tribunal, all the fees provided for in this Tariff shall be rebated by 50%".
