BIS-SAHHA tas-setgħat mogħtija bl-artikolu 16 tal-Att dwar il-Ġustizzja Amministrattiva, il-Ministru tal-Ġustizzja, Konsultazzjoni Pubblika u l-Familja għamel dawn ir-regolamenti li ġejjin:

1. (1) It-titolu ta' dawn ir-regolamenti hu **Regolamenti tal-2012 li jemendaw ir-Regolamenti dwar it-Twaqqif ta' Elenki fit-Tribunal ta' Revizjoni Amministrattiva u dawn ir-regolamenti għandhom jinqraw u jinftiehm u haġa waħda mar-Regolamenti dwar it-Twaqqif ta' Elenki fit-Tribunal ta' Revizjoni Amministrattiva, hawn iżjed 'il quddiem imsejġha "ir-regolamenti prinċipali".** Titolu.

(2) Dawn ir-regolamenti għandhom jidhlu fis-seħh fl-1 ta' April, 2012.

2. Il-paragrafi (d) u (e) tas-subregolament (5) tar-regolament 3 għandhom jiġu sostitwiti b'dan li ġej: Emenda tar-regolament 3 tar-regolamenti prinċipali.

"(d) l-Att dwar l-Amministrazzjoni tat-Taxxa;

(e) l-Att dwar Dazju tas-Sisa;

(f) l-Att dwar it-Taxxa tad-Dwana u tas-Sisa; u

(g) l-Att dwar it-Taxxa fuq il-Valur Miżjud."

L. N. 90 of 2012**ADMINISTRATIVE JUSTICE ACT
(CAP. 490)****Administrative Review Tribunal (Establishment of Panels)
(Amendment) Regulations, 2012**

IN exercise of the powers conferred by article 16 of the Administrative Justice Act, the Minister for Justice, Dialogue and the Family has made the following regulations:-

Title. **1.** (1) The title of these regulations is the Administrative Review Tribunal (Establishment of Panels) (Amendment) Regulations, 2012 and these regulations shall be read and construed as one with the Administrative Review Tribunal (Establishment of Panels) Regulations, hereinafter referred to as "the principal regulations".

(2) These regulations shall come into force on the 1st April, 2012.

Amendment of regulation 3 of the principal regulations.

2. Paragraphs (d) and (e) of sub-regulation (5) of regulation 3 shall be substituted by the following:

- "(d) the Income Tax Management Act;
- (e) the Excise Duty Act;
- (f) the Customs and Excise Tax Act; and
- (g) the Value Added Tax Act."
