## ADMINISTRATIVE JUSTICE ACT

## (CAP. 490)

**Refund of Value Added Tax To Taxable Persons Not Established in  
Malta But Established In Another Member State (Amendment)  
Regulations, 2012**

IN exercise of the powers conferred by article 21 of the Administrative Justice Act, the Minister for Justice, Dialogue and the Family has made the following regulations:-

Title.                   **1.** (1)     The title of these regulations is the Refund of Value Added Tax To Taxable Persons Not Established in Malta But Established In Another Member State (Amendment) Regulations, 2012 and these regulations shall be read and construed as one with the

(2) These regulations shall come into force on the 1st April, 2012.

Amendment of regulation 23 of the principal regulations.           **2.**     The words "Value Added Tax Appeals Board" in regulation 23(2) of the principal regulations shall be substituted by the words "Administrative Review Tribunal".
