**TRAFFIC REGULATION ORDINANCE  
(CAP. 65)**

**Motor Vehicles (Driving Licences) (Amendment)  
Regulations, 2012**

IN exercise of the powers conferred by article 54 of the Traffic Regulation Ordinance, the Minister for Infrastructure, Transport and Communications, after consultation with the Authority for Transport in Malta, has made the following regulations:-

**1.** (1) The title of these regulations is the Motor Vehicles (Driving Licences) (Amendment) Regulations, 2012, and these regulations shall be read and construed as one with the Motor Vehicles (Driving Licences) Regulations, hereinafter referred to as "the principal regulations".

Citation and commencement.

(2) These regulations shall come into force on 26th March, 2012.

**2.** Part 2 of the Second Schedule to the principal regulations shall be substituted by the following:

Amends the Second Schedule to the principal regulations.

"Part 2

Obtaining or holding a driving licence with effect from the 19th January, 2013

(a) Subject to paragraph (b), the minimum ages for obtaining or holding a driving licence shall be the following:

Column 1 Category	Column 2 Age in years
AM	18
A1, A2	18
A (in respect of motorcycles)	20
A (in respect of tricycles with a power exceeding 15kW)	21
B1, B, B Automatic, BE	18
C1, C1E	19
C, CE	21
D1, D1E	21
D, DE	24

(b) Where a person holds a certificate of professional competence in terms of the provisions of Part IV of these regulations, the minimum age for obtaining or holding the relative driving licence shall be as follows:
