**MERCHANT SHIPPING ACT
(CAP. 234)**

**Merchant Shipping Act (Amendment of First Schedule)
Regulations, 2012**

IN exercise of the powers conferred by articles 6(2) and 374 of the Merchant Shipping Act, the Minister for Infrastructure, Transport and Communications, with the concurrence of the Minister of Finance, the Economy and Investment has made the following regulations –

Title and commencement.

1. (1) The title of these regulations is the Merchant Shipping Act (Amendment of First Schedule) Regulations, 2012, and they shall be read and construed as one with the First Schedule to the Merchant Shipping Act, hereinafter referred to as “the First Schedule”.

(2) These regulations shall be deemed to have come into force on the 1st June, 2011.
